

## Entrance Screening - COVID

**SCREENERS: All persons entering the building must have their temperature taken and be asked about each symptom listed below. All should sanitize hands and be provide with surgical mask or approved N95 before entering. This includes patients, visitors, employees, and contractors.**

★ **Do you have any of the following symptoms? / ¿Tiene alguno de los siguientes síntomas?**

- Fever / Fiebre **\*\*If a patient screened with an infrared thermometer presents with a fever, re-take the temperature with an oral thermometer. \*\***
- New Cough / Nueva Tos
- Shortness of breath or difficulty breathing / Dificultad para respirar
- Chills / Escalofríos
- Muscle Aches / Dolor muscular
- Headache / Dolor de cabeza
- Sore Throat / Dolor de garganta
- New loss of taste or smell / Nueva pérdida de sabor u olfato
- Congestion or runny nose / Congestion o moqueo
- Nausea or vomiting / Nauseas o vomitos
- Diarrhea / Diarrea

★ **Have you been tested for COVID-19 in the last 10 days? / ¿Se le ha hecho la prueba de COVID-19 en los últimos 10 días?**

a. **If yes, what were the results / ¿cuáles fueron los resultados?**

★ **Within the past 10 days, have you been in close physical contact (6 feet or closer for a cumulative total of 15 minutes over 24 hours) with a person who: a) Tested positive for COVID-19? b) Is being tested for COVID-19 and is waiting for results? c) Has any symptoms of COVID-19?**

**En los últimos 10 días, ¿ha estado en contacto físico cercano (6 pies o más cerca durante un total acumulado de 15 minutos durante 24 horas) con una persona que: a) Dio positivo en la prueba de COVID-19? b) ¿Se ha hecho la prueba de Covid-19 y está esperando resultados de la prueba? c) ¿Tiene algún síntoma de COVID-19?**

**If the patient answers “YES” to any of the above symptoms, has been exposed to someone with known or suspected COVID, or if the patient had a positive or pending COVID result : DO NOT** turn patient away. Provide the patient with a surgical mask and call the Point of Contact, typically a nurse, at your health center or department to further assess the patient. Keep the patient 6 feet away from others and obtain patient’s cellphone number, name, and date of birth. We do not retest for confirmation after a positive COVID19 test. Nurse will assess patient and decide if patient should be seen outside, in car, in clinic with PPE, or sent home and scheduled for telehealth visit and reschedule routing preventative care after isolation/quarantine.

**If the patient has no symptoms, no known exposures, and had a negative result if tested,** the patient can enter the building.
