Sublocade can only be ordered, dispensed to, and administered by Addiction Medicine (ADM). Suboxone tablets are restricted to ADM.

COVID-19 Vaccine (Pfizer-BioNTech) - Monovalent	COVID-19 Vaccine (Pfizer-BioNTech) - Bivalent	Products are stored separately within the AMB clinics with LASA stickers and color-coded signage.

hydr <b>ALAZINE</b> (Apresoline)	hydr <b>OXY</b> zine (Vistaril) hydro <b>CHLORO</b> thiazide (Microzide)	Products are stored separately in the pharmacy with LASA stickers (hydro <b>OXY</b> zine and hydro <b>CHLORO</b> thiazide stored by name brand) and in the ADCs. Tall man lettering.
<b>HYDRO</b> codone/acetaminophen 5/325 mg	HYDROcodone/acetaminophen 10/325 mg	VCMC/SPH Pharmacy inventory restricted to Vicodin 5mg/325mg and Norco 10mg/325mg strengths. Products listed by name brand in ADCs. Tall man lettering. Barcode scanning.

oxy <b>CODONE</b> IR	oxy <b>CODONE</b> ER (Oxycontin)	Products listed by name brand in ADCs. Tall man lettering.
