Element 3: Drug Product Labeling	Ensure that all un-labeled medications are labeled before a procedure	OR labeling audit (NPSG 03.04.01)
Element 4: Packaging & Nomenclature	Recognize the medications that are at risk for Look-Alike/Sound-Alike and ensure safety measures are in place so as not to confuse them	Number of LASA med errors/100,000 doses dispensed
Element 5: Compounding	Ensure medications that are compounded within the pharmacy are labeled accurately and prepared following USP <797> and USP<800> guidelines.	 Quality assurance of compounded sterile products Audit of sterile compounding products
	Ensure the environment and equipment used in sterile compounding is properly maintained with corresponding documentation	 Audit of procedural workflows (EVS and pharmacy) Audit of sterile compounding documentation
Element 6: Dispensing	Monitor Pyxis overrides to ensure medications are delivered in a safe and timely manner.	 # of Pyxis overrides/# of medication removes from Pyxis Pharmacy Pyxis override audit

Element 7: Distribution	Ensure medications are appropriately loaded into Pyxis.	Pyxis refill: barcode scanning compliance
Element 8: Administration	 Improve the use of Barcode Administration rates across all of the inpatient care areas. Ensure safe and appropriate medication administration 	 Bar code administration rates Med Pass Observation Audits Alaris Pump Audit (Basic vs guardrail infusion)
Element 9: Education	Strive to involve Pharmacy in medication education within the acute care setting	 Pharmacy led education (Orientation, Nursing new hire, Skills labs, Residency fair, Residency Core Conference, ICU, and ID RPh in-services)

Element 11: Medication Use	Ensure antibiotics are properly dosed and given preoperatively and re-dosed intra-operatively.	Antibiotic Stewardship Committee: Peri-operative Antibiotic Review
